For full season stalls, the full vendor fee is due **before** the first day of the season, as well as the signed Terms of Agreement, Code of Conduct, and current Insurance Paperwork. **If you will be required to pay the Electrical Surcharge as spelled out in the**

**Terms of Agreement, it is due with the vendor fee.** If all paperwork and associated fees are not in the hands of the manager before 9:45 a.m. on the morning of the first day of the market season, set up will not be allowed.
